



**Le grand dialogue national annoncé par le président Paul Biya, dans un discours le 10 septembre dernier, se tiendra du 30 septembre au 4 octobre prochain.**

En effet, des parties prenantes ont été appelées à donner leur contribution en vue du dialogue. Jusque-là, plusieurs consultations ont eu lieu entre le premier ministre et l'opinion. Dans le même ordre d'idée, les activistes de la diaspora au nom de la « brigade antisardinard » ont exigé la libération de Maurice kamto, la libération de leaders séparatistes et un cessez le feu permanent dans les régions anglophones.

La « brigade » insiste qu'elle ne prendra part au dialogue qu'en cas de respect des conditions posées pus haut.

Ces propositions font partie de bien d'autres, reçues par le chef du gouvernement depuis la semaine dernière pour un bon déroulement du dialogue.

Par ailleurs, selon le quotidien d'expression anglaise THE SUN, les ressortissants anglophones réclament pour leur part, le fédéralisme à 10 Etats, un system de présidence interchangeable entre francophones et anglophones, la libération des leaders séparatistes emprisonnées à vie, l'existence d'un médiateur neutre pour le dialogue...

Press Release

Following the speech by Paul Biya about an open consultation leading to a National Dialogue to resolve the crisis in the Northwest and Southwest regions of Cameroon, by the end of the month of September 2019, **The Brigade Antisardinards USA (BAS USA)** would like to inform the Cameroonian People and the general public that any dialogue that does not respect the formal prerequisite comprised in the final resolution presented at the **Game Over in Washington DC on June 22<sup>nd</sup> 2019** is useless, and a total waste of time as this cannot resolve the actual crisis in Cameroon

Those prerequisites are the following:

1. The Liberation of the President elect Maurice Kamto, as well as all Political Prisoners arrested during the peaceful protest in Douala on the 26th and 28th of January, and the 1st and 8th of June 2019;
2. The liberation of Sisiku Ayuk Tabe and all of Anglophones Prisoners from the Cameroon Prisons;
3. An effective ceasefire with no preconditions in the Northwest and Southwest regions of Cameroon.

The Brigade AntiSardinards USA understands the importance of an all inclusive dialogue to get out of the situation, but remains committed to the application of these minimal preconditions without which it will be impossible to resolve the actual crisis in Cameroon.

Unless these above mentioned preconditions are met by the regime of Yaounde, The BAS USA, will not participate in any dialogue, and will remain defiant of Paul Biya and cronies to remain in power. We will escalate our citizens rights to protest, and to denounce on an international level, to a level not yet witnessed.

Additionally, The B.A.S. USA is calling on any members of the Cameroonian diaspora residing in the United States in particular, to stay away from any so called "consultation of national dialogue" at the Cameroon Embassy in Washington DC, and at the Permanent Mission of Cameroon at the United Nation in New York..

We strongly believe that the lack of governmental willpower to stop the genocide, to resolve the political and humanitarian crisis in Cameroon in a way to serve the actual interests of the Cameroonian people has not been met, and, what we have going on here, is yet another manoeuver to "buy time" and remain in power, while keeping all of his opponents away.
