 Suspending the circulation of motorbikes within certain Subdivisions
 of the North West Region till further notice.

MINDFUL of the Constitution;
 MINDFUL of Law N° 90/054 of 19th December 1990, of maintenance of Law and Order;
 MINDFUL of Decree N° 70/DF/264 of 04th June 1970 bearing on the Internal State Security;
 MINDFUL of Decree N° 2008/376 of 12th November 2008 to lay down the Administrative Organization of the Republic of Cameroon;
 MINDFUL of Decree N° 2008/377 of 12th November 2008 defining the attributes of Heads of Administrative Units and the Organization and Functioning of their Services;
 MINDFUL of Decree N° 2012/109 of 14th March 2012 appointing Mr. LELE LAFRIQUE TCHOFFO DEBEN Adolphe as Governor of the North West Region;
 CONSIDERING the exigencies of security, the preservation of peace and the maintenance of law and order;

HEREBY ORDERS AS FOLLOWS

SECTION 1: As from the date of signature of the present order, the circulation of motorbikes is hereby suspended till further notice within the following Subdivisions:

- **Batibo** Subdivision and **Widikum** Subdivision of Momo Division;
- **Balikumbat** Subdivision of Ngoketunja Division.


SECTION 2: During this period, motorbikes shall not be allowed to circulate both during the day and at night.

SECTION 3: This measure shall not apply to administrative bikes, those engaged in security operations by the forces of law and order, and those in possession of special authorizations to circulate.

SECTION 4: Any person(s) who violate or attempt to violate this order shall be prosecuted according to the laws and regulations in force.

SECTION 5: The Senior Divisional Officers of Momo and Ngoketunja and the Forces of Law and Order of the Divisions concerned shall be charged with the strict implementation of this order which shall be registered and communicated where need be./-
